It's interesting that you bring up the postal law, because Benedict XVI appointed us all postmasters and postal union judges, and James Thomas McBride subsequently issued the Postal Union Treaty of the Americas in 2010 trying to put an end to the worst abuses of color of law titles and maritime salvage liens being assessed against Americans. Since then, there have been two cases I've been party to (one IRS, one foreclosure) where the "U.S." or its agencies actually did enforce the Federal law, but it seems to be purely a matter of how educated the individuals are who are responsible for administration. 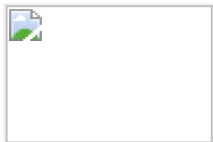

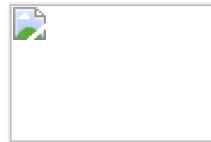
